ఖాట్వాండు, సెప్టెంబర్ 8: నేపాల్ రాజధాని ఖాట్వాండు నిరసనలతో అడ్డుపెట్టబడింది. కేపీ శర్మ ఓల్ ప్రభుత్వ అవినీతి, 26 సోషల్ మీడియా యాప్స్పై నిషేధానికి వ్యతిరేకంగా యువత కదం తొక్కింది. పెద్ద ఎత్తున వీధుల్లోకి వచ్చి తమ సురక్షాన్ని తెలియజేశారు. ధర్మ కార్యాల పట్టుకుని పార్లమెంట్ వైపు రాల్చిగా వెళ్లడం. వారు వెళ్లగానే వీలు లేకుండా పోలీసులు బారెకేడ్లు ఏర్పాటు చేసి, నిషేధాన్ని విధించారు. అయినా నిరసనకారులు బారెకేడ్ల దూకి పార్లమెంట్ భవనంలోకి కొచ్చుకొట్టడం ప్రయత్నించారు. పార్లమెంట్ గేట్ కు నిప్పు పెట్టారు. దీంతో నిరసనలను అదుపుచేసేందుకు పోలీసులు టీయర్ గ్యాస్, వాటర్ కెనాస్టు ప్రయోగించారు. పోలీసుల దాడుల్లో 20 మంది మృత్యువాతపడడం.. 25

एमएससीआई उभरते बाजारों (ईएम) के इंडेक्स में भारत का भार करीब दो साल के निचले स्तर पर आ गया है। इसकी वजह घरेलू शेयरों का कमजोर प्रदर्शन है जिससे वैश्विक निवेशकों द्वारा व्यापक रूप से ट्रैक किए जाने वाले बेंचमार्क में इसकी स्थिति कमजोर हो गई है।

अगस्त के अंत में भारत की हिस्सेदारी 16.21 फीसदी रही जो नवंबर 2023 के बाद से सबसे कम है। यह जुलाई 2024 के अपने उच्चतम स्तर 20 फीसदी से भारी गिरावट दर्शाती है। तब यह सूचकांक के सबसे बड़े भार वाले चीन से महज 4.5 फीसदी दूर था। भारत एक पायदान फिसलकर ताइवान के बाद तीसरे स्थान पर आ गया है।

वैश्विक बाजारों में मजबूत रुख के बीच देसी शेयर बाजार सोमवार को चढ़े। बीएसई सेंसेक्स में 76 अंक की तेजी रही जबकि एनएसई निफ्टी 32 अंक उछला। इस महीने अमेरिकी फेडरल रिजर्व की तरफ से नीतिगत दर में कटौती की उम्मीद से वैश्विक बाजारों में तेजी आई, जिसका घरेलू बाजार पर सकारात्मक असर पड़ा। कारोबार के आखिरी घंटे में निवेशकों की मुनाफावसूली के बावजूद बीएसई सेंसेक्स 76.54 अंक यानी 0.09 फीसदी की बढ़त के साथ 80,787.30 अंक पर बंद हुआ।

सेंसेक्स बढ़त के साथ खुला और बाद में वाहन, पेट्रोलियम और निजी बैंक शेयरों में तेजी के साथ 460.62 अंक यानी 0.57 प्रतिशत चढ़कर 81,171.38 अंक के उच्चतम स्तर पर पहुंच गया था। हालांकि, आईटी और एफएमसीजी के शेयरों में बिकवाली ने अंत में बढ़त को सीमित कर दिया।

उधर, एनएसई निफ्टी 32.15 अंक यानी 0.13 फीसदी की मामूली बढ़त के साथ 24,773.15 अंक पर बंद हुआ। सेंसेक्स की कंपनियों में टाटा मोटर्स में सबसे ज्यादा 3.97 फीसदी की तेजी रही जबकि महिंद्रा ऐड महिंद्रा 3.96 फीसदी चढ़ा। इसके अलावा मारुति, अदाणी पोर्ट्स, बजाज फाइनेंस और अल्ट्राटेक सीमेंट के शेयरों में भी इजाफा हुआ।

दूसरी तरफ, ट्रेड में 3.81 फीसदी की गिरावट आई। एशियन पेंट्स, एचसीएल टेक, टेक महिंद्रा, एलएंडटी, टीसीएस, पावर ग्रिड और सन फार्मा के शेयर भी प्रमुख रूप से नुकसान में रहे।

जियोजित इन्वेस्टमेंट्स लि. के शोध प्रमुख विनोद नायर ने कहा, घरेलू बाजार अपनी शुरुआती बढ़त बरकरार नहीं रख सका क्योंकि सत्र के आखिर में हुई बिकवाली ने गिरावट पर खरीदारी व तेजी पर बिकवाली की प्रचलित रणनीति को प्रतिबिंबित किया। इससे निवेशक सतर्क दिखे। जीएसटी दरों में कटौती के बाद मांग में सुधार की उम्मीद में वाहन और कलपुर्जा कंपनियों के शेयरों में तेजी जारी रही, जबकि वैश्विक अनिश्चितताओं के बीच आईटी शेयर कमजोर रहे।



उन्होंने कहा, अमेरिका में नौकरियों के कमजोर आंकड़ों से सितंबर में फेडरल रिजर्व द्वारा ब्याज दरों में कटौती की उम्मीद बढ़ने के बाद वैश्विक स्तर पर धारणा कुछ मजबूत हुई है। बीएसई में सूचीबद्ध 2,286 कंपनियों के शेयरों में तेजी रही जबकि 1,940 में गिरावट दर्ज की गयी। 181 के भाव में कोई बदलाव नहीं हुआ।

रॉलेयजर ब्रोकिंग लि. के वरिष्ठ उपाध्यक्ष (शोध) अजित मिश्रा ने कहा, बाजार ने सप्ताह की शुरुआत सकारात्मक रुख के साथ की और मिलेजुले संकेतों के बीच मामूली बढ़त के साथ बंद हुआ। उन्होंने कहा, निफ्टी 24,800 अंक के ऊपर मजबूती के साथ खुलने के बाद दिन भर धीरे-धीरे ऊपर की ओर बढ़ता रहा। हालांकि, अंतिम घंटे में भारी मुनाफावसूली ने बढ़त को कम कर दिया। जीएसटी दर में कटौती के सकारात्मक संकेतों और अमेरिकी फेडरल रिजर्व के उदार संकेतों से निवेशकों की धारणा को मजबूती मिली।

एशिया के अन्य बाजारों में दक्षिण कोरिया का कॉस्मी, जापान का निक्केई, चीन का शांघाई कम्पोजिट और हॉन्गकॉन्ग का हैंगसेंग सकारात्मक दायरे में रहे। यूरोप के प्रमुख बाजारों में दोपहर के कारोबार में तेजी का रुख था। शुक्रवार को अमेरिकी बाजार गिरावट के साथ बंद हुए थे। अमेरिका में जारी आंकड़ों के अनुसार, गैर-कृषि क्षेत्र में केवल 22,000 नौकरियां जुड़ीं, जबकि बेरोजगारी दर 4.2 फीसदी से बढ़कर 4.3 फीसदी हो गई। इन कमजोर आंकड़ों से अमेरिकी फेडरल रिजर्व के ब्याज दर घटाने को लेकर उम्मीद बढ़ी है।
